DELEGATION AND RECEPTION OF FACULTIES

To the Reverend Deacon Scott

The Anglican Diocese of Malek possesses your canonical license for sacramental and pastoral ministry.

Bishop Joh has sent to the Anglican Union your request and his authorization that your canonical license be extended so you may be released to serve as a *Member* of *The Anglican Union: A Confraternity of International Oratories*.

Be it known that this license is recognized and received for ministry in this Anglican Union through this Letter of Faculties and that pursuant to this *Delegation and Reception of Faculties* you are so delegated for mission and ministry in this Confraternity, effective this 2nd *day of November, Two Thousand and Twenty Three* .

This document mandates that obligations and precedents for sacramental norms lie with the Anglican Diocese of Malek. Those obligations along with the norms of the *Anglican Union*, as promulgated in the Constitution and Norms, remain in effect until expressly revoked by your licensing bishop, myself, my delegate or successor.

This *Delegation and Reception of Faculties* will be reviewed every three years. Witness my hand and seal on this 2nd *day of November, Two Thousand and Twenty-Three the Year of Our Lord*.
